



Data protection notice

EU Sustainable Energy Week (EUSEW)

17-21 June 2019

Your personal data are processed in accordance with Regulation (EU) 2018/1725¹ on the protection of individuals with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.

The data controller of the processing operation is the Head of the Administration Unit of the Executive Agency for Small and Medium-sized Enterprises (EASME).

The legal basis for the processing operations comprises Article 5(a) of Regulation (EU) 2018/1725 whereby processing is necessary for the performance of a task carried out in the public interest on the basis of the Treaties or other legal instruments adopted on the basis thereof², and Article 5(d) of Regulation (EU) 2018/1725 based on your consent for non-compulsory personal data specified below.

The purpose of this processing operation is to organize and manage the **EU Sustainable Energy Week activities**. It covers:

- Registration and management of participants to events in the framework of the **EU Sustainable Energy Week** and to provide access to venues and inclusion in the participant lists;
- Management of applications for the EUSEW Awards (evaluation, selection, announcement, promotion and feedback);
- Management of applications for hosting the Policy Conference sessions (evaluation, selection, announcement, promotion and feedback);
- Management of applications for the Networking Village (evaluation, selection, announcement, promotion and feedback);
- Management of registration to the Energy Days (evaluation, selection, announcement, promotion and feedback);
- Management of follow-up meetings and other related follow-up actions, such as the collection of feedback, the distribution of contact lists, invitations, news, reports, other

publications and information material and emails informing on future activities related to EUSEW;

- Management of the EUSEW Community – a database of titles, first names, last names, organisations, functions and mailing preferences – for receiving further information related to the topic and activities of the EU Sustainable Energy Week.

The following personal data are collected: title, first name, last name, date of birth, ID number (only for security screening to allow access to building), organisation, function, (professional/personal) e-mail address, phone number, Twitter and LinkedIn accounts. This information is **mandatory** for the purposes outlined above (except for phone number, Twitter and LinkedIn accounts which are based on your prior consent or where differently stated, e.g. EUSEW Community).

Please note that the events of the EU Sustainable Energy Week will be partly **webstreamed** and it is possible that you might be recorded/filmed/photographed. This material will be used for online and offline communication activities related to the EU Sustainable Energy Week during and after the event. Upon registration, you can give your explicit consent to have your images recorded and published on any communication channel. In the absence of your consent, the organiser will try to find suitable alternatives, so that you can fully take part in the event, e.g. offer an alternative room to follow the event by means of live webstreaming displayed on a screen.

The recipients of your data will be relevant EASME and European Commission staff in charge of the organisation of the event and the follow-up communication activities, EUSEW partner organisations², security agents of the European Commission and/or external venues security personnel, EASME's contractor ICF Mostra (and its subcontractors) involved in the organisation of the event and the follow-up communication activities, and bodies charged with monitoring or inspection tasks in application of EU law (e.g. internal audits, Court of Auditors, European Anti-fraud Office – OLAF), as well as participants of EUSEW. Participants of EUSEW may electronically receive the list of participants (including only your first name, last name, organisation, function, email).

Your data will be kept for a maximum period of **twelve months** after the end of the conference. Data will be deleted at the end of this period. As part of the EUSEW Community, your data will be kept for five years after the end of the Horizon 2020 programme and you can unsubscribe at any moment through a dedicated link present in all emails sent to you.

You have the right to access your personal data, the right to rectify any incorrect, inaccurate or incomplete personal data and where applicable, to obtain the erasure of your data. Where processing is based on your consent, you have the right to withdraw your consent at any time without affecting the lawfulness of processing based on consent before its withdrawal.
